Greetings from Sheldon Christian! We are excited to inform you that we are instilling a Chromebook Policy.

Each 4th through 8th-grade student will have a Chromebook computer this school year. We plan on assigning a specific Chromebook to each student. The Chromebooks will be used at school only (with the exception of distance learning situations) and be kept in their homeroom each evening to charge for use the next day. All Chromebook content is filtered at SCS.

Chromebooks align very well with Google Docs software. Many of our Middle School teachers are already having our students use Google Docs to do their classroom work. We believe that having these Chromebooks and using Google Docs will further prepare our students for High School.

Your child is responsible for his or her Chromebook here at school.

If your child's Chromebook is damaged or abused in any way, your family will be responsible for the repair of this device. We certainly understand that repairs and maintenance are always going to be part of any device that is used at school, but the school will not pay for anything that is not deemed as "normal maintenance and repair" (i.e. broken screen, etc.- as determined by a Premier Networking Solutions representative). The principal will discuss Chromebook 'mishaps' with the student as they occur. Depending on the situation, you may be assessed a replacement fee. A Chromebook is valued at \$330.
